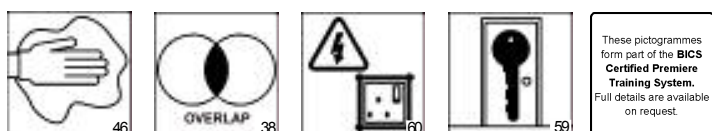

INTRODUCTION

The Premiere range of ozone friendly aerosol products designed to meet most housekeeping needs in hotels, halls of residence, nursing homes and other residential premises. These products are also suitable for use in commercial premises for the routine care and maintenance of furniture, washable hard surfaces, internal glazing (including mirrors) and fixtures and fittings in offices, classrooms and shops etc.

A chewing gum remover for the removal of chewing gum and other sticky substances from carpets, floors, upholstery and all hard surfaces.

DIRECTIONS

Always wear the appropriate protective clothing and read product label and Safety Data Sheet before use.

APPLICATION

Shake can and remove attached straw tube from aerosol can. Place tube into nozzle and spray onto chewing gum or sticky substance for 5 seconds. When white frost appears, chip away with a blunt knife or scraper. On completion brush or vacuum away.

Avoid any inhalation of airborne mist when using aerosol spray products.
